Board members agreed they would like a tour of the new green house. Culvert on 240<sup>th</sup> has been replaced and bridge inspections will be done in January or February. Recycle Roundup is set for August 27<sup>th</sup>.

Comprehensive Plan Discussion: Doug explained the Comprehensive Planning and zoning and the differences. He explained the Comprehensive plan from the West Central Wisconsin Regional Planning Commission must include 9 components. These include Agricultural, Natural and Cultural Resources. Economic Development, Energy and Sustainability, Utilities & Community Facilities, Housing, Population. Transportation and Land Use. Transportation was read as an example. Doug explained the cost from WCWRPC was \$25,000 plus the costs of mailings, meeting notices, etc. Doug agreed to head this up and get people to join the committee to work on the plan, He explained that he would try to get a cross section of the community on the committee and the board agreed to let him try to find the people and come before the board at a future meeting.

Discussion of selling used culverts. Randy Hattamer has asked to buy some of the old culverts out at the pit and he would give us more than scrap price. Board decided to sell him the culverts for \$350.00

CLERK'S REPORT : OPERATOR LICENSES: Motion by Doug and seconded by Dave to accept operator licenses. Motion passed

BUILDING PERMITS: there were six permit that were reviewed.

BILLS: Dave motioned to approve the August bills as presented and Doug seconded. Motion passed.
